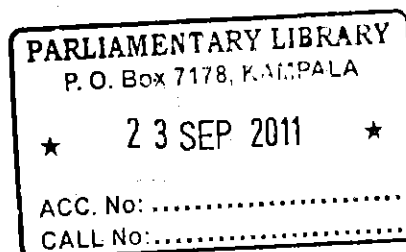

# REPORT OF THE BUDGET COMMITTEE ON THE SUPPLEMENTARY APPROPRIATION BILL 2011

## 1.0 Introduction

Rt Hon Speaker,

The Minister of Finance , Planning and Economic Development presented to this House the Supplementary Appropriations Bill, 2011 in accordance with Article 156 (3) of the Constitution which provides that, "where, in respect of any financial year, a supplementary estimate or supplementary estimates have been approved by Parliament in accordance with Clause (2) of the said article, a supplementary Appropriation Bill shall be introduced into Parliament in the financial year next following that financial year to which the estimates relate, providing for the appropriation of the sums so approved for the purposes specified in those estimates."

The Bill was referred to the Committee on Budget for scrutiny and it is my pleasure to present the Committee report.

## 2.0 Methodology

The Budget Committee met to scrutinize the Supplementary Appropriation Bill 2011. It scrutinized the supplementary expenditure schedule No. 1 No 2 and No 3 to establish if the figures as indicated in the Bill were those that were supplied to the spending agencies.

Below are the observations that arose from the discussions held.

### **3.0 Object of the Bill**

The Bill is to provide for supplementary appropriation out of the Consolidated Fund under section 16 of the Public Finance and Accountability Act, 2003 of a sum of one thousand, nine hundred ninety three billion, seven hundred seventy nine million, two hundred eighty four thousand shillings only to meet additional expenditure for the financial year 2010/2011.

### **4.0 Observations and Recommendations**

The Committee ascertained that the Supplementary Appropriation Bill, 2011 is consistent with approved supplementary schedules 1,2 and 3 save for Vote 007 Ministry of Justice and Constitutional Affairs where only Ugx 201,519,240 was approved by Parliament.















You may recall that the Budget Committee in its report on Schedule 3 recommended that only the amount of Ugx 201,519,240 already spent on the arbitration between Heritage Gas Ltd Vs Attorney General under Ministry of Justice and Constitutional be approved. The Balance of Ugx 11,740,764,666 held on an in Bank of Uganda titled "Heritage arbitration – Ministry of Constitutional Affairs", should be appropriated through the

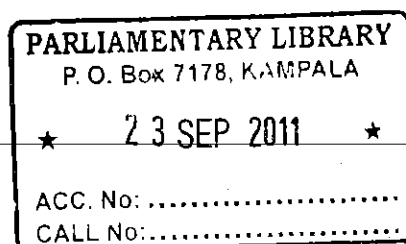
normal budget process. Government was therefore advised to reverse the entries.

In Conclusion the Committee recommends that the Bill entitled, the Supplementary Appropriation Bill, 2011, be passed into law subject to the following amendment.
