A REPORT OF THE COMMITTEE ON FINANCE, PLANNING AND ECONOMIC DEVELOPMENT ON THE ANTI-MONEY LAUNDERING (AMENDMENT) BILL, 2022

1.0 Introduction

The Anti-Laundering (Amendment) Bill, 2022 was read for the first time on 23rd August, 2022 and in accordance with Rule 129 (1) of the Rules of Procedure of Parliament was referred to the Committee on Finance, Planning and Economic Development.

Rt. Hon. Speaker, the Committee has considered the Bill and we beg to report.

2.0 Methodology

The Committee held meetings and received memoranda from the following:

- a) Ministry of Finance, Planning and Economic Development;
- b) Attorney General;
- c) Financial Intelligence Authority;
- d) Uganda Registration Services Bureau; and
- e) Uganda Revenue Authority

3.0 Object of the Bill

The object of the Bill is to amend the Anti-Money Laundering Act, 2013 to empower the Financial Intelligence Authority and supervisory authorities to levy administrative penalties for breach of the provisions of the Act; and for related matters.

The Committee observed that the Bill intends to empower:

- a) Accountable persons to take appropriate steps to identify, assess and monitor its money laundering, terrorism financing and proliferation financing risks; and
- b) The Financial Intelligence Authority and supervisory authorities to levy administrative penalties for breach of the provisions of the Act

4.0 Defects in the Principal Act

The Committee noted that the assessment of Uganda's Anti-Money Laundering legal and regulatory regime lacked sanctions for natural or legal persons who fail to comply with Anti-Money Laundering requirements.

5.0 Remedies Proposed in the Bill

The Committee observed that the Bill intends to amend:

- a) Sections 6A of the Anti-Money Laundering Act, 2013 to require accountable person to take appropriate steps to identify, assess and monitor money laundering, terrorism financing and proliferation financing risks; and
- b) Section 21A of the Anti-Money Laundering Act, 2013 to empower the Financial Intelligence Authority and supervisory authorities to levy administrative penalties for breach of the Act.

6.0 Conclusion

The Committee recommends that the Bill be passed.
