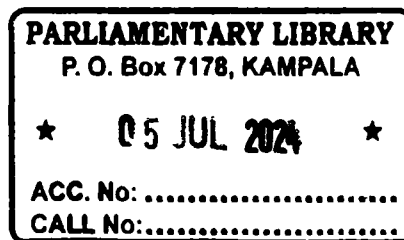

**THE REPUBLIC OF UGANDA****THE SUPPLEMENTARY APPROPRIATION ACT, 2024**

An Act to make supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015 of a sum of two trillion, nine hundred and fifty nine billion, one hundred and thirty one million, five hundred and twenty five thousand, nine hundred and twenty nine shillings only, to meet additional expenditure for the first, second, third and fourth quarters of the financial year 2022/2023.

BE IT ENACTED by Parliament as follows:

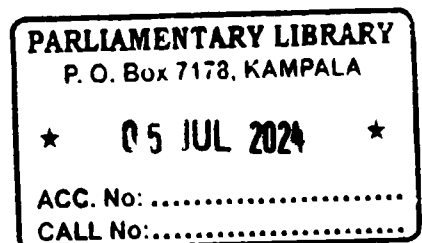
Date of Commencement:

1. Supplementary appropriation

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2022/2023, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is allowed and confirmed.

2. Commencement.

This Act shall be deemed to have come into force on the 1st day of July, 2022.

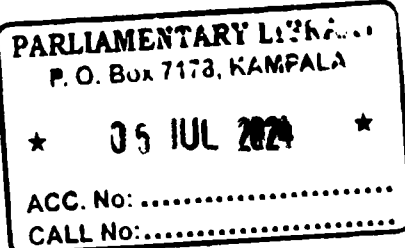
