A Bill for an Act

ENTITLED

THE SUPPLEMANTARY APPROPRIATION ACT, 1997.

An Act to make Supplementary Appropriation out of the Consolidated Fund to service of the year 1997.

BE IT ENACTED by Parliament as follows:

PART I—PRELIMINARY.

- 1. This Act may be cited as the Supplementary Citation. Appropriation Act, 1997.
