THE APPROPRIATION BILL, 2021

MEMORANDUM

An Act to apply a sum of twenty-three trillion, eight hundred eighty five billion, seven hundred fifty-nine million, eight hundred twenty four thousand shillings only out of the Consolidated Fund; to issue out of the Petroleum Fund to the Consolidated Fund a sum of two hundred billion shillings only to the service of the year ending on the 30th June, 2022 and to appropriate the supplies granted.

A BILL for an Act

ENTITLED

THE APPROPRIATION ACT, 2021

An Act to apply a sum of twenty-three trillion, eight hundred eighty five billion, seven hundred fifty-nine million, eight hundred twenty four thousand shillings only out of the Consolidated Fund; to issue out of the Petroleum Fund to the Consolidated Fund a sum of two hundred billion shillings only to the service of the year ending on the 30th June, 2022 and to appropriate the supplies granted.

BE IT ENACTED by Parliament as follows:

1. Commencement.

This Act shall come into force on the 1st day of July, 2021.

2. Issue of money out of the Consolidated Fund.

The Treasury may issue out of the Consolidated Fund and apply towards the supply granted to the Government for the service of the year ending on the 30th June, 2022 the sum of twenty-three trillion, eight hundred eighty five billion, seven hundred fifty nine million, eight hundred twenty four thousand shillings only.

3. Issue of money out of the Petroleum Fund.

There is issued out of the Petroleum Fund to the Consolidated Fund to apply towards the supply granted to the Government for the service of the year ending on the 30th June, 2022 the sum of two hundred billion shillings only.

4. Appropriation.

The sums granted by this Act shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule to this Act.

5. Expiry of appropriations.

- (1) Any part of the sums granted by section 2 of this Act which has been, or is issued from the Consolidated Fund on or before the 30th day of June, 2022 shall expire and cease to have any effect at the close of the financial year for which it is made.
- (2) A vote that does not expend money that was appropriated to the vote for the financial year shall, at the close of the financial year, repay the money to the Consolidated Fund in accordance with section 17 of the Public Finance Management Act, 2015.
- (3) Any part of the sum issued out of the Petroleum Fund to the Consolidated Fund granted by section 3 which is not withdrawn from the Petroleum Fund by the end of the financial year shall be retained in the Petroleum Fund in accordance with section 59 of the Public Finance Management Act, 2015.
