**THE SUPPLEMENTARY APPROPRIATION BILL, 2023**

**MEMORANDUM**

The object of the Bill is to provide for supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015, of a sum of four trillion, four hundred and sixteen billion, seven hundred and eighty-six million and four hundred and ninety thousand shillings only to meet additional expenditure for the financial year 2021/2022.

A BILL for an Act

**ENTITLED**

**THE SUPPLEMENTARY APPROPRIATION ACT, 2023**

**An Act to make supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015 of a sum of four trillion, four hundred and sixteen billion, seven hundred and eighty-six million and four hundred and ninety thousand shillings, to meet additional expenditure for the first, second, third and fourth quarters of the financial year 2021/2022.**

**BE IT ENACTED** by Parliament as follows:

**1. Supplementary appropriation**

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2021/2022, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.

**2. Commencement.**

This Act shall be deemed to have come into force on the 1<sup>st</sup> day of July, 2021.
