

A Bill for an Act

ENTITLED

THE SUPPLEMENTARY APPROPRIATION ACT, 2017.

An Act to make supplementary appropriation out of the Consolidated Fund under article 156(3) of the Constitution and section 25 of the Public Finance Management Act, 2015 of a sum of eight hundred eighty-eight billion, eight hundred sixty million, four hundred fifty-five thousand, two hundred eighty-two shillings only, to meet additional expenditure for the first, second, third and fourth quarters of the financial year 2015/2016.

BE IT ENACTED by Parliament as follows:

1. Supplementary appropriation.

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2015/2016, for the purposes specified in column 1 of the schedule to this Act, of the sums respectively specified in column 2 of that Schedule, is hereby allowed and confirmed.
