THE APPROPRIATION BILL, 2025

MEMORANDUM

The object of this Bill is to provide for the authorisation of public expenditure from the Consolidated Fund of a sum of forty trillion, seven hundred forty nine billion, four hundred twenty five million, four hundred forty one thousand shillings only, to meet the expenditure for the year ending 30th June, 2026 and to appropriate the supplies granted.

A Bill for an Act

ENTITLED

THE APPROPRIATION ACT, 2025

An Act to apply a sum of forty trillion, seven hundred forty nine billion, four hundred twenty five million, four hundred forty one thousand shillings only to meet expenditure for the year ending 30th June, 2026 and to appropriate the supplies granted.

BE IT ENACTED by Parliament as follows:

1. Commencement

This Act shall come into force on 1st July, 2025.

2. Issue of money out of Consolidated Fund

The Treasury may issue out of the Consolidated Fund and apply towards the supply granted to the Government for the service of the year ending on 30th June, 2026 the sum of forty trillion, seven hundred forty nine billion, four hundred twenty five million, four hundred forty one thousand shillings only.

3. Appropriation

The sums granted by this Act shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule to this Act.

4. Expiry of appropriations

- (1) Any part of the sums granted by section 3 which has been, or is issued from the Consolidated Fund on or before the 30th day of June, 2026 shall expire and cease to have any effect at the close of the financial year.
- (2) A vote that does not expend money that was appropriated to the vote for the financial year shall, at the close of the financial year, repay the money to the Consolidated Fund in accordance with section 16 of the Public Finance Management Act, Cap. 171.
