#### A Bill for an Act

#### **ENTITLED**

## THE APPROPRIATION ACT, 2023

An Act to apply a sum of twenty-nine trillion, seven hundred fifteen billion, five hundred seventeen million, one hundred ten thousand shillings only to meet expenditure for the year ending 30<sup>th</sup> June, 2024 and to appropriate the supplies granted.

BE IT ENACTED by Parliament as follows

#### 1. Commencement

This Act shall come into force on the 1st day of July, 2023

# 2. Issue of money out of Consolidated Fund

The Treasury may issue out of the Consolidated Fund and apply towards the supply granted to the Government for the service of the year ending on 30<sup>th</sup> June, 2024 the sum of twenty-nine trillion, seven hundred fifteen billion, five hundred seventeen million, one hundred ten thousand shillings only

## 3. Appropriation

The sums granted by this Act shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule to this Act

# 4. Expiry of appropriations

- (1) Any part of the sums granted by section 3 which has been, or is issued from the Consolidated Fund on or before the 30<sup>th</sup> day of June, 2024 shall expire and cease to have any effect at the close of the financial year
- (2) A vote that does not expend money that was appropriated to the vote for the financial year shall, at the close of the financial year, repay the money to the Consolidated Fund in accordance with section 17 of the Public Finance Management Act, 2015
