**THE APPROPRIATION BILL, 2018.**

**MEMORANDUM.**

The object of this Bill is to provide for the authorisation of public expenditure from the Consolidated Fund of a sum of Twenty Trillion, Seven Hundred Forty Five Billion, Eight Hundred Thirty Million, Two Thousand Shillings to meet expenditure for the financial year ending on 30th June, 2019.

A Bill for an Act

ENTITLED

**THE APPROPRIATION ACT, 2018.**

**An Act to apply a sum of Twenty Trillion, Seven Hundred Forty Five Billion, Eight Hundred Thirty Million, Two Thousand Shillings out of the Consolidated Fund to the service of the year ending on 30th June, 2019 and to appropriate the supplies granted.**

BE IT ENACTED by Parliament as follows:

**1. Commencement.**

This Act shall come into force on the 1st day of July, 2018.

**2. Issue of money out of the Consolidated Fund.**

The Treasury may issue out of the Consolidated Fund and apply towards the supply granted to the Government for the service of the year ending on 30th June, 2019, the sum of Twenty Trillion, Seven Hundred Forty Five Billion, Eight Hundred Thirty Million, Two Thousand Shillings.

**3. Appropriation.**

The sums granted by this Act shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule to this Act.

**4. Expiry of appropriations.**

(1) Any part of the sums granted by section 2 of this Act which has been, or is issued from the Consolidated Fund on or before the 30th day of June, 2019 shall expire and cease to have any effect at the close of the financial year for which it is made.

(2) A vote that does not expend money that was appropriated to the vote for the financial year shall, at the close of the financial year, repay the money to the Consolidated Fund in accordance with section 17 of the Public Finance Management Act, 2015 Act No.3 of 2015.
