A BILL for a Statute

ENTITLED

THE APPROPRIATION STATUTE, 1990

A Statute To Apply A Sum Of Shs. 241,110,377,000 Out Of The Consolidated Fund To The Service Of The Year Ending On The 30th June, 1991 And To Appropriate The Supplies Granted.

BE IT ENACTED by the President and the National Resistance Council as follows:

1. This Statute may be cited as the Appropriation Statute, Short title 1990 and shall be deemed to have come into operation on the and 30th June, 1990.

2. The Treasury may issue out of the Consolidated Issue of Shs Fund towards making good the supply granted to the Government for the service of the year ending on the 30th June, 1991 the sum of two hundred and forty-one billion, one hundred and ten million, three hundred and seventyseven thousand shillings.

The sums granted by this Statute shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule hereto.

Duration of appropriation extended in certain cases. Cap. 149. 4. Any part of the sums granted by section 2 of this Statute which has been, or issued from the Consolidated Fund on or before the 30th day of June, 1991, shall be available until a date to be determined by the Secretary to the Treasury (not being later than the 31st day of October, 1991) for making payments which become due during the year ending on the 30th day of June, 1991, to an accounting officer or a receiver of revenue or to an officer administering a fund established under section 17 of the Public Finance Act.
