A Bill for an Act

ENTITLED

THE NATIONAL YOUTH COUNCIL (AMENDMENT) ACT, 2002.

An Act, to amend the National Youth Council Statute, 1993 to provide for the recomposition of the National Youth Council, the National and District Youth Committees, and other matters related to the foregoing.

BE IT ENACTED by Parliament as follows-

1. This Act may be cited as the National Youth Council Sh (Amendment) Act, 2002 and shall be read as one with the National Youth Council Statute, 1993 in this Act referred to as the "principal enactment".

Short title.

2. The principal enactment is amended by repealing Amendment of section 5.

Amendment of section 7. 3. Section 7 of the principal enactment is amended by inserting after paragraph (b) of subsection (5) the following new paragraphs—

- (c) the District Youth Officer responsible for gender affairs at the District;
- (d) youth members of Parliament".

Amendment of section 7. 4. The principal enactment is amended by substituting for section 8 the following—

"Composition of the Council

- 8.(1) The National Youth Council shall consist of—
 - (a) the Chairperson of every District Youth Council;
 - (b) the Secretary for female at the District level; and

 (c) fourteen representatives of youth organisations elected by the National Forum for Youth Organisations;

(d) four student representatives elected by the National Students Association, two of whom shall be female;

(e) one youth member of Parliament elected by youth members of Parliament; and

(2) The National Youth Council shall meet twice a year".

Amendment of section 9. 5. Section 9 of the principal enactment is amended by adding after subsection (5) the following new subsections—

National Youth Council (Amendment) Bill

"(6) Where the office of a member of the National Youth Council falls vacant by virtue of death, over age, resignation, abscondment, or any other cause, for more than six months, the secretary shall, as soon as possible, supervise elections and fill the vacant position in the relevant council and the secretary shall notify the Electoral Commission of the results.

(7) No person shall be elected a member of any Youth Council and Youth Committee unless he or she submits a statutory declaration, or birth certificate or proves his or her age before the commencement of an election.

(8) All youth council elections at the National and District levels shall be by secret ballot".

6. Section 13 of the principal enactment is amended—

Amendment of section 13.

- (a) by adding after paragraph (c) the following new paragraph—
 - "(*d*) the Executive Secretary shall attend meetings of Executive Committee.
- (b) by adding after subsection (3) the following new subsection—

"(4) The Secretary shall be appointed by the Minister following the procedure applicable to appointments in the Public Service."

7. The principal enactment is amended by repealing Amendment of section 16.

8. The Schedule to the principal enactment is amended by Amendment of Schedule.

National Youth Council (Amendment) Bill

"(1) Except for the National Youth Executive Committee which shall meet once in three months, a youth committee shall meet for the discharge of its duties at least once every month at such time and place as the Chairperson of the Committee may direct".
